1. If required before movement, all horses will be shampooed, rinsed and allowed to dry, and their hooves will be picked clean of all solid material and washed.
2. All vehicles and equipment accompanying the horse/s will be in a clean condition at the start of travel to the **GQHPA Event at the GATTON SHOWGROUNDS**
3. All horses travelling from the cattle tick infected areas must be accompanied by the appropriate Biosecurity Queensland permits
4. In the event of horse movement restrictions, I will be responsible for the care, maintenance and cost of my horse/s including feeding and watering
5. All horses described are free of cattle ticks before entering **GQHPA Event at the GATTON SHOWGROUNDS**
6. I acknowledge that failure to comply with the above may result in refusal of entry to the **GQHPA Event at the GATTON SHOWGROUNDS**
